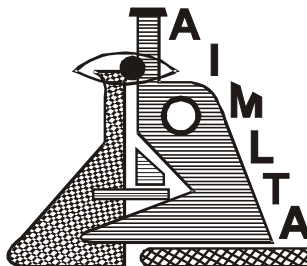

Technologists. This association undertake various social welfare health programme to serve the poor section of society by and large and coordinate with National and International agencies which are working in Lab. Medicine field with its objective "Health for all" and to support all the Welfare Health Development Programme sponsored by Govt. of India and respective State Govt.

Member from UAE, KSA, Qatar, Bahrain, Nepal, UK, USA, Sri Lanka, Bangladesh, Canada, Bhutan are seeking information for membership on our website exceeding more than 3500 (Three thousand five

hundred) & more than 1420 (One thousand four hundred twenty) registered which is remarkable achievement for AIMLTA. For all these prospect. AIMLTA has submitted a National Policy Draft (NPD) to the Union Ministry of Health and Family Welfare, Govt. of India and also to different State Govt. Health Ministry for maintaining uniformity with regard to recruitment, promotion, pay structure, job description, hazards risk allowance, non-practicing allowance, HPCA (Hospital Patient Care Allowance) training and job oriented refresher course, opening of MLT Training Inst. at National Level and many other social and technical programmes have been placed before the govt. for consideration.

Council for Med. Lab. Technologists - Our central office bearers have been keeping the demand for a separate Council (Medical Laboratory Technologist Council) through correspondence and presentation before the Honorable Ministers, Secretary and Director level officials of the Health and Family Welfare Department.

However when the Bill was being passed in the Rajya Sabha and Lok Sabha, the representatives of the association were camping at Nirman Bhawan in Delhi.

On June 3rd, there was a meeting for the Central Register Entry, the information about that also came from the Central Ministry and our Delhi State Secretary Mr. Suryadev ji remained physically present there and the office bearers of the Central Committee registered their presence online. As a result, data was collected from all over the country and sent as much as possible for registration in the Central Register. There is a need to work hard on the National Commission for Allied and Healthcare Professionals in the country and the State so that the office bearers of our association get a place within the Council. So that you can keep your point directly in the meeting. "State Level Allied Health Care Council" is going to be formed soon in many States, the office bearers of the association are required to pay more attention for it. Academic Activities of the Association : AIMLTA is dedicated and committed for the development of the MLT training programme in the country and it has introduced various MLT training programme to produce skilled and technically qualified personnel in the field of Med. Lab. Technology to cope the growing demand of trained Med. Lab. Tech. in the fast growing health care system and National Health Programme of the country. Academic Board, AIMLTA is playing a key role in training programme and has introduced one year and two years DMLT courses and

PGDMLT for student members and in-service members through its recognized affiliated MLT training institutions in different States of the country and every year **1800 to 2000 MLT trained** personnel are passing out successfully to manage pathology labs in Govt. and Non-Govt. organization. Apart from this short terms refresher course and CEP programme for the members of the association have also been introduced under Academic Board, AIMLTA. This training programme is very fruitful for medical lab. professionals.

For professional skill and for quality assurance, the association is also considering the vital aspects of Accreditation of Laboratory functioning in India in accordance with W.H.O. programme. Even to serve and help the poor section of society, association is organizing various health camps regularly (pathological investigation for diagnostic treatment) including Blood Donation Camp in different States and also organizing scientific seminars and workshops for the development of Med. Lab. Technology and Technologists of India.

We have to demand from the State Governments to arrange Internship for those students, getting training from Academic Board, AIMLTA recognised Institutions so that they should develop their skills.

Examiners are being request to take on-line classes from time to time for the skill development of the students of Institute affiliated from Academic Board, AIMLTA. On being successful on this pattern, for the students studying in the Government colleges also a negotiation can be initiated with the State Governments.

Lab technologist working in Government, Non-Government and corporate sector can take training from NABL also for skill enhancement.

International Conference : The membership fee of IFBLS has been deposited and renewed for the year 2023. Our duty is to visit IFBLS website regularly to get information about international conference wherever organised and try to participate in the conference.

GENERAL SECRETARY, AIMLTA REPORT (Discussion and Members' opinion) :

Devendra Prasad, General Secretary, AIMLTA presented his report before the Central Executive Committee of AIMLTA, and provided printed copy of the same to all CEC members including State Secretaries, Zonal Secretaries, members of Academic Board, AIMLTA and special invitees. The comprehensive report of G.S. was covering wide range of subjects relating to organizational network programme, Academic programme and also other demands which have been placed before the Central and State Govts for the welfare of Medical Lab. Technologists of India. The General Secretary reports reveals Association National Policy draft and demand of Council for Medical Lab. Technologists, DMLT course run by AB, AIMLTA, recognition and registration of AIMLTA and Academic Board by Ministry of Health and Family Welfare, Govt. of India, State Election programme, Re-constitution of Academic Board, AIMLTA, International affairs, Life membership for NRI Med. Lab. Technologists and Indian Med Lab. Technologists working abroad, date fixation of 43rd A.I.C. & S.S., State Secretaries problem, scientific work and financial proposals. The finalization of Association's policy and action plan in the contexts of G.S. AIMLTA reporting, CEC members reviewed and discussed in lengths.

In the context of GS report recommendation, acceptance or rejection, Consideration and approval in accordance with agenda. The following agenda was taken up for consideration.

1. **Organisational Network** wing is working in the States of the country but some States and Union territories of India are yet to be explored such as Sikkim, Nagaland, Meghalay, Arunachal Pradesh, Manipur, Ladakh, Jammu & Kashmir, Goa, Puducherry, Lakshadweep and Uttarakhand where State units are essentially to be established. Further more, the State units are required to be re-oriented and re-organized in Goa, Gujarat, Tripura, Assam, Tamil Nadu, Delhi and West Bengal. — **Accepted**
2. **Life membership drive** is progressing well. Presently, the total strength of Life member of AIMLTA including student member is **31180** (Thirty one thousand one hundred eighty). Despite of it more efforts should be made vigorously to increase the strength of Life members almost in all States especially covering defunct States. AIMLTA State Chapter of Bihar, Chandigarh, Maharashtra, Madhya Pradesh, Punjab and Uttar Pradesh have conducted massive membership drive in their respective States which is undoubtedly appreciable. GS emphasized to all State units of AIMLTA to start vigorous membership drive on war footing. — **Accepted**
3. **NRI Medical Lab. Technologists** affinity towards AIMLTA is increasing day by day. A large number of NRI and Med. Lab. Technologists working outside country are registering their name as life member of AIMLTA. Such membership online registration is increasing in leaps and bounds, presently **1420** (one thousand four hundred twenty) members had been registered which is remarkable and perceptible. Henceforth, for all these prospect AIMLTA has submitted a “**National Policy Draft (NPD)**” to the Union Ministry of Health and F.W., Govt. of India and also to different State Govt. Health Ministry for maintaining uniformity with regard to recruitment, promotion, pay structure, job description, risk allowance, NPA, training and job oriented refresher course, opening of MLT training Inst. at National Level and many other social and technical programmes have been placed before the Govt. for consideration and execution.
4. It is being suggested that the **format of Life membership** should be re-structured with minor changes and amount of money also be increased and decided. GS referred to consider the issue in next CEC meeting. — **Considered**
5. General Secretary ascribed that all State Secretaries of their respective States should submit online, the comprehensive **life member list** mentioning the name (Capital letters), head quarter address, L.M. number, professional qualification, working place and cell phone number excluding discontinued membership. The list shall reach as soon as possible to the office of General Secretary, Patna.

8. AIMTLA is an important members of **International Federation of Biomedical Science (IFBLS)**, Hamilton, Ontario, Canada and every time supporting the policy and programme of IFBLS. The membership fee for IFBLS was pending with **AIMTLA** since long due to Covid-19 catastrophe. Thus, the fee has already been deposited and renewed for the year 2023. The members interested in World Congress of IFBLS (Conferences) may visit the AIMTLA website and apply through proper channel as per provisions of AIMTLA. The association may sponsor the Life Member AIMTLA with financial grant whose scientific paper being accepted by the International Federation. — **Considered**
9. The memoranda **“The council for Medical Lab. Technologists”** of India had been submitted to Union Ministry of Health & FW, copy of which to Health Secretary / Director General of Health Services, Govt. of India, Nirman Bhawan, New Delhi-110001 vide Letter No. AIMTLA/GS/30/2019, dt. 09.02.2019. There is need to work hard further on the Allied Health Professional Council (2021). So that office bearer of AIMTLA may get place in the comittee. Lab. Technology. — **Considered**
20. **Formation of High Power Committee** : The implication of this objective and its phenomenal complexity shall be determined by formulating the criterion on which selection be based. Hypothetically it cannot be implemented. **(To resolved still further and Recommended)**

Jharkhand : Mr. D.D. Prasad, newly elected Zonal Secretary, Zone "A", AIMLTA presented and submitted his report to all members participants. Jharkhand state progress in respect of membership drive is very slow and only 10 (Ten) life member being enrolled by Mr. D.D. Prasad. Despite past record of 135 Life Member he assured to improve membership drive in near future. He also informed in addition, that the State Celebrated "Lab. Technician Day" supported by Mr. Akhileshwar Prasad, Mr. Ramashish Singh, Mr. Rajiv Ranjan and Mr. Mantu Nag. Mr. Ramashish Singh expressed his gratitude to all office bearers of the association for the support and ensured his affinity with AIMLTA and to render his sincere services whenever be needed.

Karnataka : Mr. M.M. Shivashankar, State Secretary, AIMLTA and Mr. H. Puttaraju, CEC, Karnataka State unit presented jointly their report and provided the printed copy of the same to all members participants apprised with the development work going on to strengthen the association on organisational front and assured to increase further the Life members in the State and also NRI membership at the end of the year 2023. State unit organised several Health Checkup Camps and Blood Donation Camps under AIMLTA and KSGMLTA Banner.

Madhya Pradesh : Dr. Govind Tripathi, State Secretary, AIMLTA State Unit, MP presented his report and provided printed copy of the same to the members participants and apprised with the development of the association activities in the State MP. The State having 51 district has been covered during membership drive and membership strength has raised in various district such as Gwalior, Ratlam, Indore, Khargon, Dewas, Chindwara, etc. MP State unit hopefully expecting from CEC regarding fulfilment of the commitments of purchasing new office at Bhopal for organisational Network programme.

Maharashtra : Mr. Kailash Pawar on behalf of State Secretary, AIMLTA, Maharashtra State Unit presented progress report of the State and Mr. R.D. Landge, Zonal Secretary, AIMLTA Zone "B" apprised the association activities and informed that membership drive is in full swing in Maharashtra State with active support and co-operation of state members without additional demands. State Unit had organised several Lab. Tech. meeting in different Medical College and Hospital to motivate membership drive of the association. The successive progress of AIMLTA in the state can be observed. In the year 2022 Life member 500 was enrolled in 2022 and 60 more Life member and 2 NRI member of AIMLTA had been enrolled at the end of Dec. 2022. After election 100 new members are registered as Life member of AIMLTA.

Punjab : Mr. Surendra Khanna, CEC member, AIMLTA Punjab presented his report and apprised in detail about association activities and informed that more than 250 Life member have been enrolled in the State, explained that Punjab Medical Council is formed under Act 2012. General Secretary assured to provide authoritative recommendation to Mr. Surendra Khanna.

Pudducherry : Mr. J. Stephen Selvaraj, CEC Member, Puducherry presented his report and distributed the copy of the same to all members participants and informed that Life Member list had been submitted by him but yet the entry of it in Central Office register not being done. The members of Puducherry had organised Blood Donation Camp with the support of Rotary Club and Indian Red Cross Society. The AIMLTA members of Puducherry also participated in World Thalassemia Day and Indian Red Cross Day on 8th May 2023. Overall the Life membership drive in Puducherry is very slow, but he assured that the team of Puducherry will definitely give positive result and work hard in order to develop organisational activities.

Rajasthan : Mr. Bikham Chandra Jagrit, State Secretary, AIMLTA and Mr. Ram Lal Yadav, CEC Member, State Unit, Rajasthan jointly presented and distributed the report mentioning that Rajasthan Paramedical Council is not acknowledging the Diploma Award Certificate, AIMLTA and State member worried to know about Paramedical Council Formation and registration of DMLT Certificates awarded by AIMLTA.

Telangana : Dr. Mohd. Ghouse, State Secretary and Mohd. Kaleem Ullah, CEC member, State Unit, Telangana, AIMLTA presented and distributed the report to all members participants. They emphasized that Hon'ble Chief Minister Mr. KCR Guru regularised the job of 500 contractual employee working in various health division, Telangana. This is obviously a great achievement of their service effort. The State unit Telangana conducted various medical camps in which approximately 500 suffered patients availed the benefit of diagnostics test free of cost. Despite of it Blood Donation Camp was conducted on 1st May day programme. Mohd. Kaleem Ullah had been engaged in Sample Collection during Covid-19 catastrophe and collected a total of 329106 corona virus positive samples and that was estimated from 2019-2022. Mean while he was two times victim of Covid-19 infection. Govt. of Telangana acknowledged his bravery and Best Technician Award certificate awarded to him by Govt. of Telangana. The devotion of Mr. Kaleem Ullah is highly appreciated by General Secretary and All CEC members.

Tamil Nadu : Mr. S. Puglenth, State Secretary and S Manuel Babu, CEC, Tamil Nadu State presented and submitted the report to all members participants and apprised about association activities in State membership driven is progressing well. He informed that State unit office bearer assemble every month to discuss AIMLTA programme and policy. The State unit is improving in membership drive and taking the social responsibilities under health programme and academic activities awareness. Mr. S. Puglenth requested to increase the number of post of Vice-President and Zonal Secretary to represent, South, West, East and North. CEC suggested it requires constitutional amendment, hence it can be referred to constitutional head in course of time. State unit requested for more fund in consideration to work done for development of Association in State. Mr. S. Manuel Babu suggested to introduce Barcode in Diploma Marks-sheet and certificates and in website newly elected body members name, photograph and mobile no. shall be added.

Tripura : Mr. Kohinoor Roy, CEC member, AIMLTA Tripura presented his report to all members participants and apprised about AIMLTA activities in Tripura and requested General Secretary to visit Tripura to pervade organisational programme and constitute a proper AIMLTA unit in Tripura. The Ex-General Secretary Mr. A. N. Sinha who was sitting on dias expedited that Mr. K. Ghosh is no more enjoined as State Secretary, Tripura State unit, thus his name should be deleted in that old letterhead pad. Mr. Kohinoor Roy accepted and assured not to make any more correspondences these mistakes in future instructions given to him. Despite of it the participants in the meeting did not exclaimed anything regarding the issue and finally, the President AIMLTA, Mr. M.M. Dass with emphasis made it passed by the house for excluding Mr. K. Ghosh from the privileges of the association.

Uttar Pradesh : Mr. Udai Saroj Singh, State Secretary, State Unit AIMLTA, UP and Mr. Rajesh Kumar Pandey newly elected CEC member, AIMLTA presented the report and distributed the printed copy of the same to all members participants and appraised the development work going on in the State to strengthen the association on organisational front and explained that membership strength has been increased in the year 2022. At the present juncture the life member strength is 509 and to be increased more at the end of 2023. Further, to accelerate organisation network programme. GB meeting was organised on 24th Feb. 2023 and as well as on 4th March 2023 in Varanasi. The meeting was presided by General Secretary Mr. Devendra Prasad. He emphatically explained the members to work for the welfare of association with new frame of mind avoiding old habits. The State ceaselessly working hard to procure more Life members from other Districts of UP apart from Varanasi. After Election of AIMLTA 21 new Life members enrolled and continually members of State unit making sustain efforts to get more and more life members. Both of them assured that no intervening factor can resist them from the organisation work. In addition, the minister of Health and Family Welfare, UP issued an order vide order No. 1150(1)/Five-7-2016 dated 01.08.2016 that Sr. Lab. Technician, UP State may be considered as Gazetted Officer. Hence, GB is requested to look to the issue and approach to avail same benefit to those technicians working under Central Govt. Health department. The cabinet minister of UP Govt. approved the Allied Council where Paramedical Diploma holders are eligible to register their certificates. Mr. Rajesh Pandey asked for the registration of AB. AIMLTA under Govt. of India.

West Bengal : Mr. Subhashish Mukhopadhyay, CEC member AIMLTA State unit AIMLTA WB presented and distributed his report to all members participants informing that injustice has done with W.B. State unit. He raised those points which were already implemented in CEC meeting. He explained that the State, is not receiving financial & organisation support since so many years and thus facing hindrances to accomplish organisation activities in the State. He also mentioned that to procure Life members in WB in reality a challenge to roll on, as many of the founder members are aligned with the association but now new born unit runs a paralleled All India Association with its Academic activities too and we are deprived to expand the AIMLTA in our State. It is requested to new central body to extend co-operation and eliminate obstacles and help State bodies to re-organise and expand the association districtwise as may be the case. In the year 2019 the state unit organised state conference and scientific seminar and state body was expected financial help from association for such scientific affairs, but experienced negative result from AIMLTA. General Secretary referred that state unit of WB was constituted on 13th Jan 2007 at B.R. Singh Rly. Hospital, Kolkata headed by Mr. Kamal Kumar Sarkar, President and Mrs. Alka Roy as State Secretary, WB (Ref. minutes of CEC meeting and 34th AIC & SS May 2007, Tata Memorial Hospital, Mumbai). Since its inception, the membership drive in WB is Statistically negligible and the progress of AIMLTA in the state is not all upto the mark. GS assured to provide necessary fund in course of time but the state unit have to take more initiative seriously in organisational programme. Defamatory report and his act of reprimand was not accepted by CEC members.

Zonal Secretary Report :

Mr. D.D. Prasad, Zonal Secretary, Zone A, Mr. R.D. Landge, Zonal Secretary, Zone-B, Mr. K.K. Mishra, Zonal Secretary, Zone-C, Mrs. B.K. Nirmala, Zonal Secretary, Zone-D, Mr. Varinder Kumar Lakhanpal, Zonal Secretary, Zone-E presented their report and apprised about the organisational activities in their respective zone. All zonal secretary expressed their satisfaction on progressive organisational and as well as Academic activities achievement. Zonal Secretary requested for fund for organisational tour and travel which will be granted on demand subject to approval of tour programme by General Secretary, AIMLTA. On account of organisational work Mr. R.D. Landge intended to visit Goa and Gujrat to re-establish unit of association because of being Dormant State Since long. Therefore, activities of association shall be created by spreading the objectives of association and by doing that above mentioned state may be capable of becoming active. Varinder Kumar Lakhanpal assured to activate three states such as Himachal Pradesh, Uttarakhand and Jammu Kashmir and make their people aware of association's activities.

All participating member expressed their views truly to achieve common goal for the development of the association.

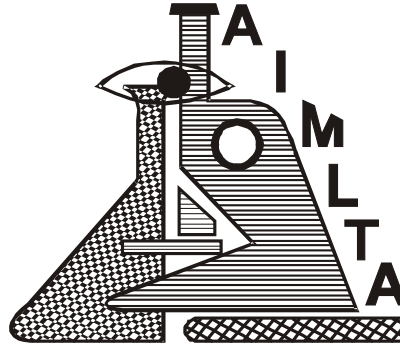
