## RULES FOR THE ELECTION

# 1. GENERAL

- **1.(a)** All bonafied members of the Association whose names are included in the Provincial list for year 2017- 2018 are eligible to contest, propose and second the nomination for any of the posts, mentioned in Election Notice 1/2020 dt. 06.01.2020/28.08.2022. The contestants must be a life members and well acquainted and have sound knowledge of the working of the Association and must have been an office bearer at District/Division/State/Central level.
- **1.(b)** The bonafied representative members of the Association, whose names are included in the provisional list for the year 2017-2018 and the regular member at the time of election, will be eligible to cast vote in the election.
- 1.© The electoral list for elections shall be provided by State Secretaries / Convenor of the respective States / Union Territory to the Central Election Officer at least before the last date for receiving the nomination form consisting of names and address of voters (State/Central) membership no. whether ordinary member/life member or office bearer. Otherwise their State/Union Territory will be debarred from voting and State Secretaries /Conveners will be responsible for it to their members.
- **1.(d)** The election for all posts, where polling is necessary, will be held directly by secret ballot.
- **1.(e)** If the number of valid nominations is equal or less than the number of posts to be filled in the person or persons, so nominated shall be declared elected unopposed and the remaining posts shall be filled up by Co-option in the New C.E.C. meeting to be held after taking over the charge.
- **1.(f)** Once the Central Election Officer has been appointed, the C.E.C. will have no right to interfere or influence the Central Election Officer till the Elections are over and the result declared.
- **1.(g)** Central Election Officer will report before the C.E.C. about the total number of nomination received post wise (Valid/Invalid).

### 2. ELECTION

- 2. (a) President, General Secretary, Treasurer, Internal Auditor and will be elected on All India basis Rule 1(a).
- **2.(b) VICE PRESIDENT**: Election will be held as per Division which is divided in two parts Div. "A" and Div."B". One Vice President will be elected from each division.
  - **Division "A"** comprising of Arunachal Pradesh, Assam, Andhra Pradesh, Telangana, Bihar, Jharkhand, Kerala, Manipur, Meghalaya, Mizoram, Orissa, Sikkim, Tamil Nadu, Tripura, Uttar Pradesh, Uttarakhand & West Bengal.
  - **Division "B"** comprising of Andaman & Nikobar Island, Daman & Diu, Delhi, Goa, Gujarat, haryana, Mimachal Pradesh, Maharashtra, Pondicherry, Punjab, Rajasthan, Chandigarh, Jammu and Kashmir, Karnataka, Madhya Pradesh, Chhatishgarh, Dadar & Nagar Haveli, Lakshdeep.

Bonafied member delegates of Div. "A" will file nomination, propose, second and cast vote for the Vice President Div. "A". Similarly Bonafied member delegates of Div. "B" will fill nomination, propose, second and cast vote for the Vice-President Div. "B".

- **2(c) ZONAL SECRETARIES:** The entire association shall be divided into five broad zones for the sake of election of five zonal secretaries. The representative member delegates of respective zones shall file nomination, propose, second and cast vote for their respective zonal secretaries.
  - **Zone A:** Arunachal Pradesh, Assam, Meghalaya, Nagaland, Manipur, Mizoram, Tripura, Bihar, Orissa, Sikkim, West Bengal and Jharkhand.
  - **Zone B:** Goa, Maharashtra, Daman & Diu, Gujarat.
  - **Zone C:** Delhi, Rajasthan, Madhya Pradesh and Chhatishgarh
  - **Zone D:** Andhra pradesh, Telangana, Tamil Nadu, Kerala, Pondicherry, Karnataka, Andaman
    - & Nikobar Island, Dadar & Nagar Haveli, Lakshdeep.
  - **Zone E:** Punjab, Haryana, Himachal Pradesh, Chandigarh, Uttar Pradesh and Uttarakhand.
- **2 (d) CENTRAL EXECUTIVE MEMBERS :** One executive member from each State / Union Territory will be elected by bonafied representative members of their respective State/Union Territory.

Nomination for C.E. members can be filled proposed and seconded by the bonafied members of their respective State / Union Territory.

# 3. FILING / WITHDRAWAL OF NOMINATIONS:

3 (a) Bonafied life members, desiring to contest election must submit their Nominations, separately for each post mentioned above in the prescribed nomination form (Specimen copy enclosed). Duly completed with all required information, leaving nothing blank and send to the Central Election Officer at the address specified, given at the last, for each post, there may be more than one nomination form. The nomination form can be photostat copy of the specimen or cyclostyled without any alteration, Additions, Cutting or Overwriting, otherwise the nomination form will be invalid and rejected. Any complaint arising of such rejection may be lodged within the period specified for withdrawal with the central Election Officer, whose decision shall be binding to all and final.

### Note: Always rechek your Nomination Form before despatch.

- **3 (b)** The nomination should be proposed and seconded by bonafied members with the written consent and declarations by the contestant, No proposer or seconder shall have right to withdraw the name of contestant so proposed or seconded after the submission of the nomination.
- **3(c)** Nomination fee of Rs. 500/- (None refundable and non-transferable). For each nomination, form must be remitted by money order to Central Election Officer at Present address and M.O. receipt be enclosed with the form otherwise the nomination form will be rejected.
- **3 (d)** All nomination form shall be sent by **Registered Post for each Post** and superscribed on the envelop "**Nominations**" at the Present address of Central Election Officer.
- **Note:** The Central Election Officer will not be responsible for any postal loss in transit of the nomination form or fee or other letters.
- **3 (e) Withdrawal :** Any contestant desirous of withdrawing his nomination from any post, must so advice in the prescribed proforma (specimen copy enclosed) within the time of withdrawal to the Central Election Officer by Registered post / on his own behalf as only in person at Ranchi (Jharkhand) on 1st day of AIC. One can contest for one Post only, otherwise his candidature will not be considered.
- **3 (f)** The candidates are required to report their presence on 1st day, of A.I.C. and also in the house at the time of election, otherwise in absence their candidature will be rejected.
  - Amendment: If the candidate declared or notified in the final list as unopoosed, the contestant shall not be considered as absent at the time of election if registered as delegate on first day.
  - **Amendment:** If the candidate declared or notified in the final list as unopposed, the contestant shall not be considered as absent at the time of election if registered as delegate on first day.
  - All such unopposed contestant declared invalied due to oversight for absence in the house be declared elected. This is decided by C.e.C. in Mysore (18th A.I.C.).
- **Note:** Unopposed and declared candidates should be present at the time of introduction to the house by the C.E.O. otherwise it will be presumed that he/she is not interested to hold the post.
- **3(g)** That in case a candidate has been registered as a delegate on the first day of A.I.C. and is absent in the house at the time of election and his absence is on account of unforeseen and unavoidable circumstances beyond his control or due to exigency of services on official grounds, then such absence will not invalidate his candidature, Provided further that such absence is communicated in writing to Central Election Officer, immediately on arising such circumstances which necessitated the absence.

# 4. POLLING:

- 4(a) All bonafied representative members, exercising the right of casting vote in the ratio of 10:1 will be required to be present at the specified place in the house at the time of election and will be required to have delegate card and to produce the latest identity slip, issued by the Contestant/ State Secretary / C.E.C the ballot paper will be issued. Other member delegates will sit on back row.
- **4(b)** All bonafied representative members, contestants, proposers, seconders should bring the original enrolment membership receipt / renewal receipt or a certificate from secretary for confirmation to their bonafidity and produce whenever asked. They must be regular bonafied member at the time of voting.

- **4(c)** Each bonafied representative member shall cast only one vote for each post from the panel of vild nominations.
- **4(d)** Immediately after the election, the casted votes will be counted in the presence of agents deputed by the candidates and successful candidate will be declared elected in order of number of votes polled for them. In case of a tie, the decision shall be lots system.

### 5. Disputes:

- Any objection to the election shall be sent to the Central Election Officer in the form of an Election Petition accompanied by a petition fee Rs. 200/- (to be remitted by Money Order) and M.O. receipt enclosed by registered post, within a fortnight of the announcement of the result.

  The petition must contain a brief statement of the material facts on which the petition relies and be accompanied by a list of evidence which the petitioner wishes to produce to prove his statements and objection.
- **5(b)** The protest note regarding the intention to file the petition should be lodged within 24 hours after the declaration of election results, otherwise the petition will not be admitted.
- **5(c)** The election petition shall be adjudged by an Election Tribunal consisting of three members on C.E.O. and two members nominated by C.E.C.
- **5(d)** The returned candidate shall be entitled to execute the right & perform duties as duly eleced person, till the Election Tribunal declares his/her election null and void.
- **5(e)** The decision of the Election Tribunal in his regard shall be final and binding on all and cannot be challenged in any Court of Law.

# 6. Publicity & Canvassing:

- **6(a)** The contestant may canvas in their favour at individual level after the announcement of final list by the Central Election Officer, but not on the election date & time and in the house, otherwise their candidature will be cancelled.
- **6(b)** Loudspeakers, posters, banners, slogans are not allowed for announcement or display as canvassing.

# 7. VACANCY:

- **7(a)** Mid term vacancy of the C.E.C. caused due to any reasons, shall be filled up by C.E.C. at its meeting amongst the C.E.C. members.
- **7(b)** In case any post remain unfilled during the election, C.E.C. can co-opt any bonafide members for the post.
- 8. The Central Election Officer, Election Sub-Committee have rights reserved for taking necessary decision, making any additions, change of rules and regulations and change in the programme of election, as and when required.
